# **Terms & Conditions - AI FaceSwap**

By downloading or using the app, these terms will automatically apply to you – you should make sure therefore that you read them carefully before using the app. You're not allowed to copy or modify the app, any part of the app, or our trademarks in any way. You're not allowed to attempt to extract the source code of the app, and you also shouldn't try to translate the app into other languages or make derivative versions. The app itself, and all the trademarks, copyright, database rights, and other intellectual property rights related to it, still belong to AI FaceSwap.

Al FaceSwap is committed to ensuring that the app is as useful and efficient as possible. For that reason, we reserve the right to make changes to the app or to charge for its services, at any time and for any reason. We will never charge you for the app or its services without making it very clear to you exactly what you're paying for.

The AI FaceSwap app stores and processes personal data that you have provided to us, to provide our Service. It's your responsibility to keep your phone and access to the app secure. We therefore recommend that you do not jailbreak or root your phone, which is the process of removing software restrictions and limitations imposed by the official operating system of your device. It could make your phone vulnerable to malware/viruses/malicious programs, compromise your phone's security features, and it could mean that the AI FaceSwap app won't work properly or at all.

You should be aware that there are certain things that AI FaceSwap will not take responsibility for. Certain functions of the app will require the app to have an active internet connection. ## **Fair Usage Policy**

Under this policy, users are permitted to swap faces in up to a maximum of **50 photos per day**. This daily limit is implemented to prevent excessive use of the app, which could impact the app's performance and availability for other users.

#### Important Details:

- The 50-photo limit resets every 24 hours from the time of your first use on a given day.
- If you exceed this limit, you will be unable to swap faces on additional photos until the limit resets the following day.
- We reserve the right to adjust this daily limit at any time without prior notice, based on user activity and app performance considerations.
- In cases where we believe that this limit is being abused, we may take appropriate actions, which could include suspending or terminating your access to the app.

This policy is designed to maintain the integrity of the AI FaceSwap app and to ensure that all users can enjoy its features without interruption. Your continued use of the app constitutes acceptance of this Fair Usage Policy.
